Features of acceptance for studies at higher education institutions for foreigners and stateless persons

- 1. Admission for studies at NTU "KhPI" of foreigners and stateless persons is carried out in accordance with the Law of Ukraine "On Higher Education", "On the Legal Status of Foreigners and Stateless Persons", "On Foreign Ukrainian", "On Refugees and Persons Who Need Additional Or Temporary Protection", by Decree of the President of Ukraine dated June 3, 1994 No. 271 "On measures for the development of economic cooperation between the regions of Ukraine and the adjacent regions of the Republic of Belarus and administrative units of the Republic of Moldova", by the Decree of Cabinet of Ministers of Ukraine dated September 11, 2013 No. 684 "Some questions of acceptance for studies of foreigners and stateless persons", by Order of the Ministry of Education and Science of Ukraine dated November 01, 2013 No. 1541 "Some issues on organization of acceptance and training (internships) of foreigners and stateless persons" registered in the Ministry of Justice of Ukraine on November 25, 2013 under No. 2004/24536.
- 2. Foreigners and stateless persons (hereinafter Foreigners) can obtain higher education at the expense of individuals and/or legal entities, unless otherwise provided by international treaties of Ukraine, the consent to which must be granted by the Verkhovna Rada of Ukraine, legislation or agreements between higher education institutions on international academic mobility.

Admission of foreigners to higher education institutions for studies at the expense of the state budget is carried out within the limits of quotas for foreigners.

3. Foreigners arriving in Ukraine for the purpose of studies enroll at higher education institutions in accredited educational programs (specialties).

The enrollment of applicants from among foreigners for studies at the expense of individuals and/or legal entities can be carried out by higher education institutions:

- 1) twice a year, before and at the beginning of academic semesters (but no later than November 01 and March 01, respectively), to obtain bachelor's and master's degrees;
- 2) throughout the year for postgraduate and doctoral studies.

NTU "KhPI" calculates the marks/grades of the applicant on the basis of the document on the previous received level of education and sets the minimum value of marks/grades required for admittance on General Subjects on which the entrance exam is held.

Enrollment of foreigners for studies at an appropriate level of higher education is based on the results of entrance examinations in certain subjects and language of education and on the basis of academic rights to continue studies provided by a document confirming the obtained education level in the country of his/her origin, and taking into account success level that give the right to continue education at the next level of higher education in accordance with the legislation of the country that issued the document on the received degree (level) of education.

- 4. All categories of foreigners, who enroll for studies, are enrolled in higher education institutions of Ukraine on the basis of enrollment orders formed in the Unified Database.
- 5. The requirements of NTU "KhPI" for compliance of applicants from a number of foreigners who arrived in Ukraine for the purpose of education, the conditions of admission to

appropriate levels of higher education, as well as the deadlines for accepting applications and documents, conducting entrance exams, creative competitions and admission are specified in the Admission Rules and published on the official website of the university.

- 6. Foreigners, who are granted state scholarships under international treaties, national programs, and other international obligations of Ukraine, are accepted for studies within the established quotas for foreigners on the basis of directions from the Ministry of Education and Science of Ukraine.
- 7. Foreigners arriving in Ukraine to participate in academic mobility programs or to obtain higher education in accordance with educational programs agreed upon between the Ukrainian and foreign higher education institutions are accepted for studies based on the relevant contractual obligations of the relevant higher education institutions.
- 8. Foreign Ukrainians, who are legally reside in Ukraine and whose status is witnessed by an identification document of a foreign Ukrainian, when enrolling at NTU "KhPI" use the same education rights as citizens of Ukraine, with the exceptions established by the Constitution of Ukraine, laws of Ukraine or international treaties, the consent to which must be granted by the Verkhovna Rada of Ukraine.

Foreign Ukrainians, whose status is witnessed by an identification document of a foreign Ukrainian, may be enrolled for studies on the state order within the established quotas for foreigners based on the interview on subjects prescribed by the Admission Rules.

9. Foreigners and stateless persons who permanently reside in Ukraine, persons who have been granted refugee status in Ukraine, and persons who need additional or temporary protection, and enroll at higher education institutions in accordance with the rules provided for in these Rules for Ukrainian citizens, may participate in the competitive selection for the state order within the quotas established by the Cabinet of Ministers of Ukraine on the basis of a special competitive grade, which is calculated as the ratio of the competitive grade of an applicant defined in accordance with cl. 8 of Section VII of these Rules, to the minimum competitive grade of provided recommendations for a budget (regional) order of a general competition for this competitive offer in the previous year (in the absence of such grade, the same indicator of the other the most similar competitive proposal is used within the higher education institution, in case of impossibility – of another higher education institution by the decision of the Admission Committee).
