
Author of over 150 publications, head of the scientific school formed in NTU "KhPI" concerning the transactions cost theory in transition economy and impact of transaction costs on inequality

## Research topic for potential cooperation with Chair of International Economics:

## "Development of international trade between Ukraine and Germany"

*Goal of research* is to compare the efficiency of practical realization of bilateral trade potential between Ukraine and Germany.

#### **Expected results:**

- 1. Assessment of potential opportunities and current state of bilateral trade between Ukraine and Germany.
- 2. Determination of comparative effectiveness as a ratio of a potential and degree of its implementation.

**Scientific novelty** consists in estimation of comparative effectiveness of international business of Ukraine and Germany by comparing indices of bilateral trade development.

**Practical significance** consists in broader realization of potential of bilateral trade between Ukraine and Germany, as well as developing practical recommendations.

## Research topic for potential cooperation with Chair in Banking and Finance:

# "Budget deficit and public debt management: implementation of experience of EU member countries for Ukraine"

*Goal of research* is to develop recommendations to improve government policy of public debt management.

#### **Expected results:**

- 1. Selection of government debt evaluation methods appropriate for Ukraine.
- 2. Exploration of possible implementation of experience of EU member countries on public debt management for Ukraine.

**Scientific novelty** of the research involves implementation of concept of "sustainability of public debt" into analysis of the current economic state in Ukraine and development of practical recommendations.

#### Practical significance involves:

- 1. Improving government policy of public debt management in Ukraine.
- 2. Providing research data on Ukrainian economy for cross-country comparisons.
